## **ODOT- I-5 Rose Quarter Acquisition and Relocation.**

MVA is a subcontractor for HDR Oregon real estate services providing Acquisition, Relocation, Project Management, for ODOT's I-5 Rose Quarter project located in Portland, Oregon.

#### **ODOT – ADA Compliance Project.**

Marco played a key role in developing and managing the processes for residential and business relocation for this large-scale project. Marco implemented methods and made recommendations to the client for the best process in residential relocation. Marco also assisted the co-manager in Business Relocation in implementing the approval process for Sound Transit in accordance with the Uniform Relocation Assistance and Real Property Acquisition Policies Act to complete the project.





## City of Seattle, Seattle Public Utilities- Assemblage Project

MVA holds a direct contract with Seattle Public Utilities for relocation and property management services. MVA is responsible for managing the relocation process, preparing the relocation plan, and conducting relocation services of displacement for the utility. Marco assists team members in the preparation of claims of the identified displaced persons, provides leadership and verification that SMC 20.84 regulations are applied and followed for each identified displacement, and works with the MVA team on recommendations to the utility for the best course of action in relocating the identified displacements, while providing advisory services to the displaced persons. MVA also carries out property management services for parcels that are vacated, makes recommendations for security, parcel clean up, necessary lease agreements. Collect property information to provide a report of each building. MVA conducts and verifies weekly site visit reports.

## City of Covington Parks and Recreation - Relocation.

MVA is tasked with assisting in the relocation of forty-six personal property-only storage spaces and one non-residential occupant. Marco manages the MVA team and provides leadership for a successful outcome.

This acquisition of properties was needed to either construct a tunnel or a new elevated structure that is intended to replace the existing earthquake-damaged SR 99 Viaduct. Marco also provided property management services to transfer the vacant acquired parcels to WSDOT. For this project, the state, City of Seattle, and the Federal Highway Administration shared responsibility. They created an integrated management team comprised of individuals from all three agencies and private consultants, including HDR, to lead the project through new and innovative project management approaches to complete the project within budget on an accelerated schedule.

Marco negotiated purchase and sale contracts for REDFIN clients. Marco would conduct property comparable market analysis and negotiate terms of a contract and if necessary, managed hold-over tenancy with temporary leases. Once the offered real estate terms were accepted by a seller, as Mutual Acceptance, then Marco would negotiate inspection results and managed all aspects of the transaction until closing. At the end of the transaction all clients were given a survey to rate their experience, Marco always ranked at the top of the customer service surveys, as well as the top percentage of deals closed in Washington. He consistently negotiated 3-6 deals per month towards successful closings.
