Sound Transit – Federal Way Light Rail Link Extensions

MVA is a subcontractor for HDR real estate services contract and provides Acquisition, Relocation, Project Management, and Right of Entry services for the Sound Transit Link Light Rail along several segments in the surrounding Seattle area. MVA provides Relocation Assistance and Advisory Services for displaced businesses and residences. MVA also provides acquisition and negotiation services that include parcel offer, right of entry access and fee and/or easement acquisitions on the necessary parcels that are within the project pathway. For these projects, the Sound Transits Management Team is comprised of HDR staff and other sub-consultant professionals to lead the multiple projects in accordance with Uniform Relocation Assistance and Real Property Acquisition Policies Act to complete the project.

Marco prepared replacement housing studies for residential displacements and relocation claims. Marco worked with both displaced persons and businesses providing advisory services to achieve a successful relocation. Marco facilitated and assisted in the relocation of a variety of businesses ranging from local restaurants to an established machine shop. Marco worked closely in the relocation of additional residential displacements including long-time homeowners and renters throughout the SeaTac and Federal Way area. Organized several vacate walkthroughs to ensure that displaced persons have met agency standards in the vacate process. Worked closely with Sound Transit Property Management to ensure a smooth transition of ownership between prior property owners and Sound Transit, as well assist in the traditional real estate aspects of relocation. Marco also acted in an advisory capacity in the creation of a new project database infrastructure to be used on future Link Light Rail projects.
